In addition, a disclosure must be added to identify the affiliation or lack thereof between any outside business entity and CoastalOne
- Broker-dealer disclosure requirements:
 - 1. RR Only: "Securities are offered through Coastal Equities, Inc., Member FINRA/SIPC, located at 1201 N. Orange Street, Suite 729, Wilmington, DE 19801."
 - 2. RR & IAR: "Securities are offered through Coastal Equities, Inc., Member FINRA/SIPC and investment advisory services are offered through Coastal Investment Advisors, Inc., a US SEC Registered Investment Advisor, co-located at 1201 N. Orange Street, Suite 729, Wilmington, DE 19801."
 - 3. **DBA RR Only**: Add the following sentence to the end of the RR Only Disclosure "Coastal Equities, Inc. is not affiliated with [DBA name here]."
 - 4. **DBA RR & IAR**: Add the following sentence to the end of the RR & IAR Disclosure "Neither Coastal Equities, Inc. nor Coastal Investment Advisors, Inc. are affiliated with [DBA name here]."
 - RR & Own RIA: "Securities are offered through Coastal Equities, Inc., Member FINRA/SIPC, located at 1201 N.Orange Street, Suite 729, Wilmington, DE 19801. Investment advisory services are offered through [RIA NAME], a US SEC Registered Investment Advisor, located at [RIA ADDRESS].
